Constitution Capital Access Fund, LLC (the “Fund”) 2026 Tender Offer Schedule

Constitution Capital PM, L.P. (the “Adviser”) anticipates recommending to the Fund’s Board of Managers (the “Board”) that, under normal market circumstances, the Fund conduct repurchase offers of no more than 5% of the Fund’s net asset value on or about each February 28, May 31, August 31, and November 30. Any repurchases of Fund shares will be made at such times and on such terms as may be determined by the Board from time to time in its sole discretion.

Shareholders of the Fund will be notified of the tender offer in a written notification from UMB Fund Services Inc., the Fund’s administrator, which will include instructions for submitting a request to the Fund to tender all or a portion of their shares. It is expected that the Fund will remit payment to tendering Shareholders within 65 days after the tender offer’s expiration date.
